

Minutes of an ordinary virtual meeting via Zoom of Bradwell Parish Council on Monday, 3rd August 2020 at 7.30pm

- i. Public Bench on Common Lane report from PSCO: this report resulted in complaints that the bench is being used for illicit purposes and BPC were invited to conduct a survey. Cllr Bradburn instigated the report as he has had 3 to 4 complaints about drinking/drugs taking place in that area. It was decided not to pursue a survey as the bench was placed there for elderly residents to rest on their way to and from the shops, it is now added to the PCSO's patrol. No further action
- ii. Rock snake Miriam Lay attended the meeting and discussed ideas for the placement of the rock snake. Miriam was advised by Cllrs to perhaps also approach the local schools. They could then put a proposal together and apply to BPC for a grant/placement of the Rock Snake. Miriam then left the meeting.
- iii. Tree behind 9 Winterburn & previous quotes from Ray Brown this was not highlighted on the tree survey, therefore Cllrs agreed to contact the residents with this information and to monitor the situation
- iv. Climate study do BPC wish to take part Councillors asked that the information is put onto our website and Facebook.
- v. Covid Support to P&TCs: noted no response.
- vi. Heelands Playing field area identified for more wild flower seeding, area by goal post that needs to filled in as 6 inches deep.

The previous quotes seem underfunded as there is no costings for outside landscaping or parking, therefore CSS will give the project a health check. It was also suggested to get quotes for both building methods Traditional & Design Build as things are more competitive since Covid-19.
