



**Minutes of the Meeting of the Full Council held on Monday 01 June 2026 at 7.00pm at the Heelands Meeting Place on Glovers Lane, MK13 7PN.**

**Councillors Present:** Gilpin (in the Chair) Alexander, Best, Bradburn, Exon, Kendrick, Muchmore and Stuchbury.

**Staff Present:** Philip Farquharson (Clerk).

**Members of the public:** 3

**FC25/26 Apologies:** Councillor Godfrey had provided an apology for absence. The reason for absence was voted upon which met with unanimous approval.

**FC26/26 Declaration of interests:** Councillors Exon and Kendrick declared interests in that they were on planning committees at MKCC and would refrain from voting on planning matters.

**FC27/26 Public participation:** It was on the agenda for any resident of the Parish to raise any issue, petition, question or concern. The following matters were raised:

- The grant application from the YMCA. Information was provided to the Council, in that there were currently at least 13 people in MK who were affiliated to the Parish, who were living in YMCA accommodation. The YMCA had rebranded to YMCA South Midlands to incorporate Northamptonshire, as they had merged areas. Agenda item FC35/26 refers to the grant application.
- Parking issues on Langcliffe Drive and the resident spoke in favour of double yellow lines at the bottom of Langcliffe Drive, opposite Flintergill Court.
- The condition of the road, and pot holes, on Langcliffe Drive.
- The speed at which motorists drive on Langcliffe Drive, and a request for speed bumps.
- A further member of the public was the newly elected ward Councillor for Bradwell Common, Jordan Coventry, who was welcomed to the Meeting.

**FC28/26 Minutes of the May 2026 Annual Council Meeting:**

**Action:** The Minutes of the May Annual Meeting held on 11 May 2026 were approved by resolution as an accurate record of the Proceedings of that Meeting. These were signed by the Chair for the Council's records.

**FC29/26 Bradwell Memorial Hall Roof:** It was on the agenda to explore options for roof replacement and insulation including renewable sources. It was noted that the previous planning application for solar panels had been refused, primarily on account of the vicinity of the Castle Motte and Bailey and that the Memorial Hall was located in the conservation area.

A motion was proposed for the Clerk (working with Councillor Best), to re-approach the Conservation Officer and seek roofing quotes if deemed appropriate by the Conservation Officer, to replace the roof and install solar panels and roof insulation:

Those in favour: 8

Against: 0

Abstain: 0

**Action:** The motion Carried.

**FC30/26 Payments:** The Council noted by formal resolution the current bank balance of £115,696 and savings account balance of £15,290 (as at 22 May 2026), and approved the monthly schedule of payments made since the last meeting.

**FC31/26 Coleshill Place Bradwell Common Zig-zag parking:** It was on the agenda to consider petitioning MKCC replacement of double-yellow lines with zig-zag markings.

A motion was proposed to petition MKCC to replace the double yellow lines with zig-zag markings, and to request 'Street Schools' at the location, pending communication and approval from Summerfields school:

Those who abstained from voting: 0

**Action:** The motion Carried and the Clerk would communicate with the school prior to petitioning MKCC.

**FC32/26 Double-yellow lines on Langcliffe Drive:**

A motion was proposed to petition MKCC to place double yellow lines at the bottom of Langcliffe Drive opposite Flintergill Court.

Those in favour:8

Those to the contrary: 0

Those who abstained from voting: 0

**Action:** The motion Carried and the Clerk would petition MKCC to place double yellow lines there.

**FC33/26 Exclusion of the Press and Public:** In view of the confidential nature of the business about to be transacted, and in accordance with the Public Bodies (Admission to Meetings) Act 1960, members of the public were temporarily excluded, at the request of the Chair and by a vote of Councillors.

**FC34/26 Complaint:** The Chair updated the Council that the complaint had been withdrawn prior to the Meeting.

**FC35/26 Grants application YMCA:**

A motion was proposed to approve the YMCA grant application for £1,000:

**FC36/26 Planning Applications:** Councillors considered making representation to MKCC on the below planning application:
